Land Acknowledgement

We would like to acknowledge with respect that the land we operate on is the traditional territory of many nations including the Mississaugas of the Credit, the Anishnabeg, the Chippewa, the Haudenosaunee, and the Wendat peoples. These lands are now home to many diverse First Nations, Inuit, and Métis peoples. As the regulator for physiotherapists in Ontario, we set rules and develop programs to ensure that members of the physiotherapy profession practice in the best interest of the public.

Every patient should have access to safe, competent and ethical physiotherapy care. We work to protect the rights of patients by continually improving the practice of more than 10,000 physiotherapists.

What We Do

REGISTRATION: Physiotherapists need to be registered with the College to practice in Ontario and they must have the appropriate qualifications.

PROVIDE INFORMATION: We help the public make informed decisions about their care by maintaining a list of registered physiotherapists called the Public Register.

ENSURE QUALITY CARE: We set the standards of practice that physiotherapists must follow, and make sure they are committed to their ongoing learning and development.

INVESTIGATE CONCERNS: We consider all complaints or concerns about physiotherapists.

Exam Exemption Policy

There was no national clinical exam offered in 2021 – 2022 due to logistical challenges related to COVID-19.

In the absence of a clinical exam, the College's Registration Committee introduced the **Exam Exemption Policy** in December 2021. This policy allowed some people with a Provisional Practice Certificate of Registration to apply for an Independent Practice Certificate of Registration without completing a clinical exam.

306 certificates were issued under this policy as of March 31, 2022, and the number continues to grow. This policy will be rescinded on March 31, 2023, when the Ontario Clinical Exam (OCE) will be available.

Quality Assurance Program Update

The new Quality Assurance program launched in January 2021.

- 676 total Screening Interviews completed (533 were Quality Assurance Screening Interviews and 143 Screening Interviews conducted as part of the Exam Exemption Policy)
- 21 Assessments based on Screening Interview results
- 14 decisions released by the Quality Assurance Committee

Support patient safety when attending a physiotherapy appointment.


Practice Advice


The Practice Advisors offer a safe place for physiotherapists, PT Residents, students, patients, employers and others to ask questions about physiotherapy practice.

The Practice Advisors addressed 6,685 inquiries in 2021 – 2022.

INQUIRIES



Review the College's Strategic Plan

College Performance Measurement Framework (CPMF) Highlights 2021



In 2020, the Ministry of Health established a new annual reporting requirement for all health regulatory colleges. The College Performance Measurement Framework (CPMF) allows us to measure and report, in a standardized way, how we are acting in the public interest.

Completing the CPMF is an opportunity for the College to reflect on our achievements, better understand how we measure up to best practices in regulation and to identify areas of improvement.

The Ministry requires us to report on seven domains that relate to how we accomplish our key statutory functions and serve the public interest. Under each domain are standards that outline best practices of regulatory excellence. Colleges will update this report annually, noting any progress on areas identified for improvement or adding new or updated information required by the Ministry of Health. After reviewing the reports, the Ministry will provide the College with performance feedback. These reports are one of the ways colleges demonstrate their commitment to the public interest for the people of Ontario.

Questions addressed by the CPMF

Question 1

How well does a College ensure that only qualified individuals who demonstrate that they are competent and safe are practicing?

Question 2

How well does a College ensure that its governance and operations are transparent, effective, and efficient in serving and protecting the public interest?

Question 3

How well does a College ensure sustained competence and quality of care is delivered by all registrants?

Question 4

How well does a College help ensure that those in need of care can access qualified health professionals when and where they need them?

Question 5

How responsive is a College in addressing the changing practice environment of its registrants?

Highlights and Important Activities for 2021

Equity, Diversity, and Inclusion

- Identified as a strategic priority for the College.
- Work will be included in all regulatory areas of the College including standards, policies, guidelines, and the Code of Ethics.
- Specific internal initiatives include sharing a land acknowledgement and position statement, adding EDI resources to the College website, a shift to gender neutral communications and qualitative research regarding the experiences of internationally educated physiotherapists.

Public Interest Rationale in Public Materials

- We now include a public interest assessment in most Council briefings.
- Ongoing work to find avenues to make public interest considerations more accessible to the public.

Data and Technology

- Large-scale project to renew database technology this continued to be a priority in 2021 and the work will extend into the next reporting period.
- Improved efficiencies for registrants and complainants that help further the College's public interest mandate.
- Next steps include a cybersecurity audit to further improve data processes.

Collaboration (System Partner Standards)

- Demonstrated collaboration with system partners to address the challenges around the unavailability of a clinical exam.
- Worked with other regulators to develop creative solutions to challenges posed with respect to the COVID-19 pandemic.

Areas of improvement for the next reporting year and beyond

Many College resources were redirected to help address the unavailability of a clinical exam. As a result, several initiatives that were planned for this reporting cycle were put on hold.

We are committed to furthering these initiatives and making these improvements where we can.

- We responded that we did not meet the measure that "Council review framework includes a third-party assessment at a minimum of every 3 years."
 - We are planning to pursue an independent review of Council effectiveness, and we hope to start that process soon.
- Risk Management we answered "not met" to the measure asking us whether we had a formal approach to risk management that is reflected in strategic planning
 - We are currently developing an Enterprise Risk Management (ERM) policy in response to the need for risk assessment and mitigation strategies.
 - Plan to share risk dashboards within management teams and present to Council during regular reporting.
- 3 Status Update on Council Decisions
 - We now include an action items list with status updates in the Registrar's Report.
- Using performance indicators such as KPIs against our strategic objectives and making their results available to the public
 - Plan to resume use of dashboards at Council meetings, which will include key risk indicators and performance in strategic projects.

Discipline Summaries 2021-2022



Discipline Hearings (April 1, 2021 to March 31, 2022)

In 2021–2022 there were 9 Discipline Hearings that took place at the College of Physiotherapists of Ontario.

Taddeo, Jason—Registration #12526 Case: 2017 0168

On December 10, 2018 the Inquiries, Complaints and Reports Committee (ICRC) referred a matter involving Jason Taddeo to the Discipline Committee for a hearing.

The hearing took place on February 24, 2021 and April 22, 2021. This matter was resolved by way of an Agreed Statement of Facts and a Joint Submission on Penalty.

Finding

The panel of the Discipline Committee issued a decision on the finding on April 22, 2021, on the penalty on April 22, 2021 and on costs on April 22, 2021.

After having considered all of the evidence, a panel of the Discipline Committee found Jason Taddeo to have committed the following acts of professional misconduct:

- Paragraph 1 (Reg 388/08) failing to maintain the standards of the profession);
- Paragraph 27 (Reg 388/08) (falsifying a record);
- Paragraph 28 (Reg 388/08) (signing or issuing a document that the Registrant knows or ought to know contains a false or misleading statement);
- Paragraph 32 (Reg 388/08) (submitting an account or charge for services that the Registrant knows or ought to know is false or misleading);
- Paragraph 18 (Reg 388/08) (engaging in conduct or performing an act relevant to the practice of the profession that, having regard to all the circumstances, would reasonably be regarded by Registrants as disgraceful, dishonourable or unprofessional

Penalty

- The panel of the Discipline Committee ordered the following penalty. That Jason Taddeo: Receive a reprimand at the conclusion of the hearing (delivered on April 22, 2021).
- Serve a suspension for the period of April 23, 2021 through to and including April 22, 2022.
- Complete a review of various College, standards, tools and resources.
- Successfully complete the ProBe program.
- Meet with a practice coach on no more than three occasions.
- The physiotherapist shall not practice as a physiotherapist assistant (PTA) during the period of the served suspended.

The panel also ordered Jason Taddeo to pay costs to the College in the amount of \$25,000 to offset some of the costs associated with investigating and prosecuting this case.

As a part of the penalty the Committee issued a reprimand which read as follows:

The panel finds that your behaviour constituted serious misconduct, and this sort of misconduct cannot be tolerated by the profession. The public interest depends on the integrity of the profession. Protecting the integrity of the profession depends on a zero-tolerance of inappropriate business practices. The submission of false statements on several occasions brings into question your honesty, integrity, and professionalism.

We trust that this experience will allow you to reflect on your actions and grow as a therapist. The panel would like to advise you that any further findings of misconduct could result in a more severe outcome than that which has been imposed here today. The panel does not expect to see you before us again.

Mathews, Darren (Darrin) Russell—Former Registration #12407 Case: 2020 0134

On January 19, 2021, the Inquiries, Complaints and Reports Committee (ICRC) referred a matter involving Darren (Darrin) Mathews to the Discipline Committee for a hearing.

The hearing took place on May 4, 2021 and adjourned sine die.

The Panel of the Discipline Committee agreed to adjourn the hearing sine die due to the Registrant having signed an Acknowledgement and Undertaking to resign his membership and certificate of registration with the College and never apply or reapply to practice physiotherapy in Ontario.

The Acknowledgement & Undertaking was signed April 29, 2021 and stated:

- I, Darren (Darrin) Mathews, acknowledge and undertake as follows:
 - 1. I acknowledge that allegations about my conduct as they relate to sexual misconduct directed towards Patient A have been raised before the Inquiries, Complaints and Reports Committee (ICRC) of the College of Physiotherapists of Ontario (the "College"). The ICRC referred these allegations to the Discipline Committee on January 19, 2021, in College Case Number 2020-0134. The hearing is pending.
 - 2. I acknowledge that on March 4, 2021, I was advised that Patient B filed a complaint about my conduct as it relates to consent, communication and sexual abuse of a patient. This matter is before the ICRC.
 - 3. This acknowledgement and undertaking does not constitute an admission of any professional misconduct, including sexual abuse.

- 4. I acknowledge and agree that, in exchange for my providing to the College an original copy of this Undertaking executed by me, the College agrees not to proceed with the current investigation into my conduct.
- 5. I acknowledge and agree that, in exchange for my providing to the College an original copy of this Undertaking, the College will ask a panel of the Discipline Committee to adjourn the hearing in College file number 2020-0134 sine die. I undertake to resign my membership and certificate of registration with the College effective May 4, 2021.
- 6. I hereby undertake never to apply or re-apply for membership, registration, licensure or similar status with the College as a physiotherapist or for a license to practice physiotherapy in Ontario.
- 7. I acknowledge that if I ever apply or re-apply, or attempt to apply or re-apply for membership, registration, licensure or similar status with the College in the future, the College will be entitled to rely upon this undertaking in any registration or other similar proceeding as reason to deny my application.
- 8. I acknowledge that if I ever apply or re-apply for membership, registration, licensure or similar status as a physiotherapist for a license to practice physiotherapy in Ontario after May 4, 2021, the College shall, in its sole discretion, have the right to proceed with a disciplinary proceeding on the basis of a breach of this undertaking and, if I am successful in being registered, the College shall also be entitled to proceed with the discipline hearing in case number 2020-0134 and the investigation of my practice based on the complaint made against me.
- 9. I acknowledge that after I resign my membership with the College, I will not be entitled to use the title "physiotherapist", "physical therapist" or any abbreviation thereof or equivalent in another language. I will not be entitled to hold myself out as a person who is qualified to practice in Ontario as a physiotherapist/physical therapist and I will not be entitled to imply that I am a physiotherapist/physical therapist in Ontario.
- 10. I acknowledge that after I resign my membership with the College I will not be entitled to practice as a Physiotherapist Assistant (PTA) or in a similar role supporting the care provided by a registered physiotherapist.
- 11. I acknowledge that the College is required to include the fact of my resignation and the fact of this Undertaking on the College register and that it will also be published on the College's website. This publication is indefinite.
- 12. In the event of a breach of this undertaking and the College proceeding with discipline hearing 2020-0134 and the current investigation(s), I hereby agree to bear the risk of any prejudice that the passage of time might cause to my ability to make full answer and defence, and waive the right to seek any remedy on the basis of the passage of time, should the College proceed with the investigation and any allegations that may arise as a result of any future breach of this Undertaking by me.
- 13. I undertake to pay \$3,000 to the College to be applied to the College's fund for therapy and counseling by June 30, 2022, which sum may be paid in instalments.
- 14. I acknowledge that I have been advised of my right to obtain legal advice prior to entering into this Undertaking and have either availed myself of that right or chosen not to avail myself of that right.

Afkari, Poneh—Registration #14709 Case: 2019 0107

On November 2, 2020, the Inquiries, Complaints and Reports Committee (ICRC) referred a matter involving Poneh Afkari to the Discipline Committee for a hearing.

The hearing took place on June 7, 2021. This matter was resolved by way of an Agreed Statement of Facts and a Joint Submission on Penalty and Costs.

Finding

The panel of the Discipline Committee issued a decision on the finding on June 7, 2021, on the penalty on June 7, 2021 and on costs on June 7, 2021.

After having considered all of the evidence, the panel found Poneh Afkari to have committed the following acts of professional misconduct:

- paragraphs 1 (failing to maintain the standards of practice of the profession)
- paragraph 18 (engaging in conduct or performing an act relevant to the practice of the profession that, having regard to all the circumstances, would reasonably be regarded by members as disgraceful, dishonourable or unprofessional)
- paragraph 26 (failing to keep records in accordance with the standards of practice of the profession)
- paragraph 27 (falsifying a record)
- paragraph 28 (signing or issuing a document containing a statement that the member knows or ought to know is false or misleading)
- paragraph 32 (submitting an account or charge for services that the member knows or ought to know is false or misleading)
- paragraph 33 (failing to take reasonable steps to ensure that any accounts submitted in the member's name or billing number are fair and accurate.

Penalty

The panel of the Discipline Committee ordered the following penalty. That Poneh Afkari:

• Receive a reprimand at the conclusion of the hearing (delivered on June 7, 2021)

- Serve a suspension for the period of June 8, 2021 through to and including April 8, 2022. The suspension could be extended if they are unable to complete certain requirements
- Complete a review of various College, standards, tools and resources
- Successfully complete the ProBe program
- Meet with a practice coach on no more than eight occasions
- May not supervise physiotherapy students, physiotherapy assistant students or registrants of the profession who hold a provisional practice certificate of registration during the coaching period
- Practice as a PTA during their suspension only under the supervision of an approved, registered member of the College who is a full-time physiotherapist in Poneh Afkari's practice location. If this is a private practice setting, this location must be owned by a regulated health professional.

The panel also ordered Poneh Afkari to pay costs to the College in the amount of \$2,500.00 to offset some of the costs associated with investigating and prosecuting this case.

As a part of the penalty the Committee also issued a reprimand which read as follows:

The panel has found that you engaged in significant professional misconduct. As a physiotherapist in a leadership role as a clinic owner, other members of the profession are influenced by your actions. In this case, you also risked the reputations and livelihood of individuals from two other healthcare professions. The conduct was unethical and brought disrepute to the profession.

The panel wants to highlight that your deficiencies in recordkeeping is a recurring behaviour. Based on the prior history with the Inquiries, Complaints and Reports Committee in 2016, this panel found that you were previously made aware of similar shortcomings; therefore, you should have been able to avoid issues related to recordkeeping.

We expect that when you return to practice, you will ensure your adherence to the standards of the profession. We expect that you will never again find yourself before a discipline panel of this College. If you do, the outcome of this proceeding will weigh heavily on any future penalty consideration.

Yee, Silvana Christine—Registration #11159 Case: 2019 0015

On September 18, 2020, the Inquiries, Complaints and Reports Committee (ICRC) referred a matter involving Silvana Yee to the Discipline Committee for a hearing.

The hearing took place on June 17, 2021. This matter was resolved by way of an Agreed Statement of Facts and a Joint Submission on Penalty.

Finding

The panel of the Discipline Committee issued a decision on the finding on June 17, 2021, on the penalty on June 17, 2021 and on costs on June 17, 2021.

After having considered all of the evidence, the panel found Silvana Yee to have committed the following acts of professional misconduct:

- Paragraph 1 (failing to maintain the standards of practice of the profession),
- Paragraph 5 (practicing the professional while the member is in a conflict of interest),
- Paragraph 18 (engaging in conduct or performing an act relevant to the practice of the profession that, having regard to all the circumstances, would reasonably be regarded by members as disgraceful, dishonourable or unprofessional)
- Paragraph 26 (failing to keep records in accordance with the standards of practice of the profession),
- Paragraph 27 (falsifying records),
- Paragraph 28 (signing or issuing a document containing a statement that the member knows or ought to know is false or misleading),
- Paragraph 32 (Submitting an account or charge for services that the members knows or ought to know is false or misleading),
- Paragraph 33 (failing to take reasonable steps to ensure that any accounts submitted in the member's name or billing number are fair and accurate) and;
- Paragraph 40 (continuing the treatment of a patient where it is no longer indicated, has ceased to be effective or is unnecessary).

Penalty

The panel of the Discipline Committee ordered the following penalty. That Silvana Yee:

- Receive a reprimand at the conclusion of the hearing (delivered on June 17, 2021)
- Serve a suspension for the period of June 18, 2021 through to and including January 17, 2022. The suspension could be extended if they are unable to complete certain requirements
- Complete a review of various College, standards, tools and resources
- Successfully complete the ProBe program
- Meet with a practice coach on no more than four occasions

- The physiotherapist may not supervise physiotherapy students, physiotherapy assistant students or registrants of the profession who hold a provisional practice certificate of registration during the coaching period
- Practice as a PTA during their suspension only under the supervision of an approved, registered member of the College who is a full-time physiotherapist in Silvana Yee's practice location. If this is a private practice setting, this location must be owned by a regulated health professional.

The panel also ordered Silvana Yee to pay costs to the College in the amount of \$4,500 to offset some of the costs associated with investigating and prosecuting this case.

As a part of the penalty the Committee also issued a reprimand which read as follows:

The panel wishes to advise you that your pattern of behaviour over the 22-month period in question will not be tolerated by this profession. Your conduct was unethical and brought disrepute to the profession. Protecting the integrity of the profession demands zero tolerance of inappropriate business practises. Your actions constitute serious and most objectionable misconduct. As a physiotherapist, it is incumbent upon you to adhere to the standards established by the College to protect the public.

We do wish to acknowledge your cooperation with the College, and that you have no prior history with the College.

The panel hopes that this experience will provide you with a chance to reflect on the behaviour that has brought you before us today. The panel has provided you with an opportunity to correct your behaviours and return to the profession. We encourage you to use the resources available to you. Should you be subject to misconduct proceedings in the future, these findings today will certainly influence the outcome at that time.

Wang, Jian Li (Johnny)—Registration #12982 Case: 2018 0052

On January 19, 2021, the Inquiries, Complaints and Reports Committee (ICRC) referred a matter involving Johnny Wang to the Discipline Committee for a hearing.

The hearing took place on August 23, 2021. This matter was resolved by way of an Agreed Statement of Facts and a Joint Submission on Penalty.

Finding

The panel of the Discipline Committee issued a decision on the finding on August 23, 2021, on the penalty on August 23, 2021 and on costs on August 23, 2021.

After having considered all of the evidence, the panel found Johnny Wang to have committed the following acts of professional misconduct:

- paragraph 1 (failing to maintain the standards of practice of the profession);
- paragraph 18 (engaging in conduct or performing an act relevant to the practice of the profession that, having regard to all the circumstances, would reasonably be regarded by members as disgraceful, dishonourable or unprofessional);
- paragraph 26 (failing to keep records in accordance with the standards of practice of the profession);
- paragraph 32 (submitting an account or charge for services that the member knows or ought to know is false or misleading);
- paragraph 33 (failing to take reasonable steps to ensure that any accounts submitted in the member's name or billing number are fair and accurate); and
- paragraph 40 (continuing the treatment of a patient where it is no longer indicated, has ceased to be effective or is unnecessary).

Penalty

The panel of the Discipline Committee ordered the following penalty. That Johnny Wang:

- Receive a reprimand at the conclusion of the hearing (delivered on August 23, 2021)
- Serve a suspension for the period of seven months. The first three months of the suspension will begin on October 1, 2021 and be completed on December 31, 2021. The remaining four months will be served as directed by the Registrar. The suspension could be extended if Johnny Wang is unable to complete certain requirements
- Complete a review of various College, standards, tools and resources
- Successfully complete the ProBe program
- Meet with a practice coach on no more than eight occasions for a two-year period Johnny Wang may not not use the title Physiotherapist, PT or any abbreviation thereof nor can Johnny Wang's name, PT title and/or registration number be use for billing purposes while serving the suspension
- Johnny Wang may not practice as a physiotherapist assistant (PTA) during their suspension

The panel also ordered Johnny Wang to pay costs to the College in the amount of \$4,000 to offset some of the costs associated with investigating and prosecuting this case.

As a part of the penalty the Committee also issued a reprimand which read as follows:

Mr. Wang, the panel has found that your behaviour has constituted professional misconduct and wishes to

comment on certain elements to remind you in the strongest possible way that your professional obligations demand that your patients' interests are always a priority, and that includes record keeping.

Focusing on record keeping, a patient record must include not only the clinical notes, but also the billing records. The sparsity of your clinical notes does not reflect clinical reasoning, though it very well may be present. The inadequacy of your records gives the impression of falsified and/or fraudulent billing behaviour.

The panel wishes to reinforce the importance of maintaining its standards in ensuring that your conduct is at all times professional. It is quite apparent that your behaviour was not a single occurrence, as you failed to demonstrate improvement following concerns raised by the third-party insurer. It is inconceivable to this panel that you were not aware of acceptable professional practice by the time the College commenced its investigation. Finally, as you are the owner of a practice, your position means that you are in a leadership role and a mentor to members of our profession. You are expected to provide care and lead in the highest ethical behaviour. Should you appear before a disciplinary panel for similar behaviour in the future, this proceeding will weigh heavily on penalty consideration at that time.

Vogel, Patricia—Registration #13677 Case: 2020 0140 and 2020 0153

On September 28, 2021, the Inquiries, Complaints and Reports Committee (ICRC) referred a matter involving Patricia Vogel to the Discipline Committee for a hearing.

Finding

The hearing took place on January 12, 2022. The panel of the Discipline Committee issued a decision on the finding on January 12, 2022, on the penalty on January 12, 2022 and on costs on January 12, 2022.

After having considered all of the evidence, the panel found Patricia Vogel to have committed the following acts of professional misconduct:

- paragraph 13 (failing to reply appropriately or within a reasonable time to a written inquiry from the College);
- paragraph 14 (contravening, by act or omission the Physiotherapy Act, 1991 the Regulated Health Professions Act, 1991 or the regulations under either of those Acts);
- paragraph 18 (engaging in conduct or performing an act relevant to the practice of the profession that, having regard to all the circumstances, would reasonably be regarded by members as disgraceful, dishonourable or unprofessional);

Penalty

The panel ordered the following penalty:

- Receive a reprimand at on a date to be fixed by the Registrar
- Serve a suspension until Patricia Vogel has successfully completed the following requirements.
- Complete a review of various College, standards, tools and resources
- Successfully complete the ProBe program

While suspended, Patricia Vogel may not use the title Physiotherapist, PT or any abbreviation thereof. Patricia Vogel also may not use their name, PT title and registration number for billing purposes while serving the suspension.

The panel also ordered Patricia Vogel to pay costs to the College in the amount of \$5,000 to offset some of the costs associated with investigating and prosecuting this case.

Khollari, Mohammad Saeed—Registration #13665 Case: 2017 0208

The hearing took place on January 26, 2022. This matter was resolved by way of an Agreed Statement of Facts and a Joint Submission on Penalty.

Finding

The panel of the Discipline Committee issued a decision on the finding on January 26, 2022, on the penalty on January 26, 2022 and on costs on January 26, 2022.

After having considered all of the evidence, the panel found Mohammad Saeed Khollari to have committed the following acts of professional misconduct:

- paragraph 1 (failing to maintain the standards of practice of the profession);
- paragraph 18 (engaging in conduct or performing an act relevant to the practice of the profession that, having regard to all the circumstances, would reasonably be regarded by members as disgraceful, dishonourable or unprofessional);

- paragraph 26 (failing to keep records in accordance with the standards of practice of the profession);
- paragraph 40 (continuing the treatment of a patient where it is no longer indicated, has ceased to be effective or is unnecessary

Penalty

The panel ordered the following penalty, Mohammad Saeed Khollari will:

- Receive a reprimand at the conclusion of the hearing (delivered on January 26, 2022)
- Serve a suspension for the period of two months, to be served on dates to be fixed by the Registrar. The suspension must be completed by December 31, 2024
- Meet with a practice coach for a maximum of eight occasions within a two-year period
- Not supervise physiotherapy students, physiotherapy assistant students or registrants of the
 profession who hold a provisional practice certificate of registration during the coaching period.
 The Registrant will be unable to supervise Residents moving forward until such time that they can
 meet the Practice Supervisor Eligibility Criteria

While Mohammad Saeed Khollari is serving their suspension they shall not use the title Physiotherapist, PT or any abbreviation thereof nor can their name, PT title and registration number be used for billing purposes.

Further, Mohammad Saeed Khollari's practice is restricted to the long-term care sector at this time.

The panel also ordered Mohammad Saeed Khollari to pay costs to the College in the amount of \$5,000 to offset some of the costs associated with investigating and prosecuting this case.

As a part of the penalty the Committee also issued a reprimand which read as follows:

Mr. Khollari, being a physiotherapist is not a right, but rather a privilege that comes with responsibilities, one of which is proper recordkeeping. Accurate and thorough recordkeeping allows us to ensure proper billing practices to facilitate continuity of care and to assist and demonstrate the clinical decision-making required to help our clients.

By your own admission and assessment by this panel, your practices in this regard have fallen below the standard and undermine the credibility of the profession. Moreover, the fact you have been sent previously to ICRC for recordkeeping issues and now sit in front of this panel shows a certain disregard for the College standards and your duties as a physiotherapist.

Subpar recordkeeping is a practice that will not be overlooked, nor will it be tolerated as it affects the quality of care that we provide our clients. Please review this as a second chance and try to learn from it. We collectively hope that we don't see you in front of the Discipline Committee again. Should you appear before a disciplinary panel in the future, this proceeding will weigh heavily on penalty consideration at that time.

Finding

The panel of the Discipline Committee issued a decision on the finding on March 8, 2022, on the penalty on March 8, 2022 and on costs on March 8, 2022.

After having considered all of the evidence, the panel found Mahmood Kalbasy to have committed the following acts of professional misconduct:

- paragraph 1 (failing to maintain the standards of practice of the profession);
- paragraph 15 (contravening a federal, provincial or territorial law relevant to the member's suitability to practice);
- paragraph 18 (engaging in conduct or performing an act relevant to the practice of the profession that, having regard to all the circumstances, would reasonably be regarded by members as disgraceful, dishonourable or unprofessional);
- paragraph 26 (failing to keep records in accordance with the standards of practice of the profession);
- paragraph 27 (falsifying a record); paragraph 28 (signing or issuing a document containing a statement that the member knows or ought to know contains a false or misleading statement);
- paragraph 32 (submitting an account or charge for services that the member knows or ought to know is false or misleading); paragraph 33 (failing to take reasonable steps to ensure that any accounts submitted in the member's name or billing number are fair and accurate);
- paragraph 40 (continuing the treatment of a patient where it is no longer indicated, has ceased to be effective or is unnecessary).

Penalty

The panel ordered the following penalty, Mahmood Kalbasy will:

- Receive a reprimand at the conclusion of the hearing (delivered on March 8, 2022)
- Serve a suspension for the period of seven months, the first two months with be served from March 31, 2022 up to and including May 30, 2022. The remaining five months will be served as directed by the Registrar
- Complete a review of tools, standards and resources
- Successfully complete (receive an unconditional pass) from the ProBE course
- Meet with a practice coach for a maximum of eight occasions within a two-year period
- Not practice as a physiotherapist assistant (PTA) during the periods of suspension

While Mahmood Kalbasy is serving their suspension they shall not use the title Physiotherapist, PT or any abbreviation thereof nor can their name, PT title and/or registration number be used for billing purposes.

The panel also ordered Mahmood Kalbasy to pay costs to the College in the amount of \$5,000 to offset some of the costs associated with investigating and prosecuting this case.

As a part of the penalty the Committee also issued a reprimand which read as follows:

Mr. Kalbasy you have been found to be in violation of the college standards. Your actions have been described as insurance fraud in this hearing. Had it not been a joint submission by you and the College, this panel would have imposed a much stricter penalty.

Your conduct is despicable and jeopardizes the future relationship between the physiotherapy profession and insurers. It undermines the integrity and brings disrepute to the profession. The College has a zero tolerance policy for inappropriate billing practices and we hope that the profession in general takes note of the serious penalties that have been imposed. The Panel is troubled by your lack of appropriate record keeping and the implication that has regarding the quality of care provided. We expect that when you resume your practice you will strictly adhere to all of the Standards of the profession.

We do wish to acknowledge your cooperation with the College, the unfortunate circumstances in your personal life, and that you have no prior history with the College. We expect you to put your full efforts into completing the rehabilitative portions of this penalty.

We do not expect to see you appear before a panel of this College again. And, I'm sure you will understand that, should you reappear for similar conduct, the consequences will be most serious.

Cunanan, Michael Jr. Q—Registration #13905 Case: 2019 0034 and 2019 0131

On April 21, 2021, the Inquiries, Complaints and Reports Committee (ICRC) referred a matter involving Michael Cunanan to the Discipline Committee for a hearing.

The hearing took place on March 25, 2022. This matter was resolved by way of an Agreed Statement of Facts and a Joint Submission on Penalty.

Finding

The panel of the Discipline Committee issued a decision on the finding on March 25, 2022, on the penalty on March 25, 2022 and on costs on March 25, 2022.

After having considered all of the evidence, the panel found Michael Cunanan to have committed the following acts of professional misconduct:

- paragraph 1 (failing to maintain the standards of practice of the profession);
- paragraph 18 (engaging in conduct or performing an act relevant to the practice of the profession that, having regard to all the circumstances, would reasonably be regarded by members as disgraceful, dishonourable or unprofessional);
- paragraph 26 (failing to keep records in accordance with the standards of practice of the profession);
- paragraph 27 (falsifying a record);
- paragraph 28 (signing or issuing a document containing a statement that the member knows or ought to know contains a false or misleading statement);
- paragraph 32 (submitting an account or charge for services that the member knows or ought to know is false or misleading);
- paragraph 33 (failing to take reasonable steps to ensure that any accounts submitted in the member's name or billing number are fair and accurate).
- paragraph 40 (continuing the treatment of a patient where it is no longer indicated, has ceased to be effective or is unnecessary).

Penalty

The panel ordered the following penalty, Michael Cunanan will:

- Receive a reprimand at the conclusion of the hearing (delivered on March 25, 2022)
- Serve a suspension for a period of ten months, the first two months with be served from March 26, 2022 up to and including May 26, 2023. The suspension could be extended if certain requirements are not met.

- Complete a review of tools, standards and resources
- Successfully complete (receive an unconditional pass) the ProBE program
- Meet with a practice coach for a maximum of eight occasions within a two-year period

While Michael Cunanan is serving the suspension, he cannot practice as a physiotherapist assistant (PTA). While serving the suspension, Michael Cunanan cannot use the title Physiotherapist, PT or any abbreviation thereof. Michael Cunanan's name, PT title and/or registration number cannot be use for billing purposes while the suspension is being served.

The panel also ordered Michael Cunanan to pay costs to the College in the amount of \$5,000 to offset some of the costs associated with investigating and prosecuting this case.

As a part of the penalty the Committee also issued a reprimand which read as follows:

The panel has found that your behaviour constituted serious misconduct and this sort of conduct will not be tolerated by the profession. Practicing physiotherapy is a privilege not a right.

While serving your suspension, it is the expectation that you will reflect on this fact.

Public interest and trust depends on the integrity of the profession. Protecting the integrity of the profession demands zero tolerance of inappropriate business practice. The nature of your actions were particularly disgraceful and unprofessional. In your case, you knowingly engaged and encouraged patients to participate in fraudulent conduct with the insurer.

The additional risk of having insurers lose confidence in the profession could result in the public suffering from the consequences of loss of access to the public for physiotherapy care.

As a physiotherapist, it is incumbent upon you to maintain the standards of the profession particularly in the matter of record keeping and standards of practice.

The panel would like to advise you that any further findings of misconduct could result in a more severe outcome than that which was imposed today. We expect that you will not appear in front of a discipline panel again.


