# About the College 2015–2016

The College of Physiotherapists of Ontario is the regulator for physiotherapists in Ontario. We believe patients have the right to safe, competent and ethical physiotherapy care.

We work to protect and serve the public interest, and to continually improve the practice of more than 8,500 physiotherapists, also known as physical therapists.

By law, we are required to:

- make certain that only qualified people can practice as physiotherapists
- ensure that physiotherapists continue learning throughout their career
- make sure that all physiotherapists meet our Standards for entry into the profession and for ongoing conduct and practice
- consider all complaints and concerns brought to the College's attention by the public

Our work is guided by the College Council, which is made up of:

- members of the public—appointed by the Lieutenant Governor of Ontario
- so physiotherapists—elected by their peers
- academic representatives who are physiotherapists—appointed by their educational institutions





### Letter from the PRESIDENT

As my second term as President comes to a close and my ninth year on Council wraps up, this letter is a good opportunity for me to look back and share some parting thoughts.

#### ENGAGEMENT

In the last four years, I have seen a dramatic increase in the dialogue between the College and physiotherapists. The conversation takes place in many ways, including comments on Shenda's Blog, responses to consultations and an increase in interested candidates running for Council.

The most recent and impressive example of this level of engagement has been the feedback from PTs on the Standards out for consultation. It's been an unprecedented response rate in health regulation. I hope this trend continues.

#### INQUIRIES, COMPLAINTS AND REPORTS COMMITTEE (ICRC)

I have sat on the ICRC every year that I have been at the College, and have read well over 1,000 case files involving PT conduct. In the early years, there were fewer cases before the Committee and the issues seemed straightforward.

Today, as we approach almost 9,000 members, the volume of cases has naturally risen. I have noticed a significant increase in the complexity and severity of the cases coming before the Committee.

We now have cases involving patient files and patterns of concerning behaviour where PTs are falling below not just one but multiple Standards of the profession. My most concerning observation is the rise of private sector business models that challenge the very definition of physiotherapy.

#### ONTARIO PHYSIOTHERAPY ASSOCIATION (OPA)

I am happy to say that I believe the working relationship with the OPA remains strong. While the two organizations have different mandates and interests, both are necessary for the profession to be well positioned, and the public to be protected.

I have enjoyed working with OPA Past President Stephen Patton for the last two years and I have absolutely no doubt that new College President, Stephen Mangoff, will continue this productive relationship with the new OPA President Wendy Smith.

I'd like to finish by thanking Council and College staff.

I don't even want to think about what the last nine years would have been like had I not taken the risk and put my name forward for a seat at the table.

### Letter from the **REGISTRAR**

Each year when it is time to prepare our annual report, I am tasked with the happy job of thinking back over our accomplishments. This year I am prouder than ever and I hope you are too.

I think that the measure of a profession might just be its participation in selfregulation and the forward momentum of the regulator. We keep getting things done and you keep pushing us forward.

#### It's amazing!

Here are some examples of what I mean about participating in self-regulation:

- More of you than ever ran in the Council elections this spring, with 13 physiotherapists running in two districts.
- Our voting rates improved to 23% participation this year, compared to 11% 5 years ago. That's more than double.

- More than 150 people provided comments on my Blog.
- More than 1,800 people contributed to the consultation about two new Standards: Performing Controlled Acts and Other Restricted Activities and Physiotherapists Working with Assistants.

And here are examples of what I mean about pushing regulation forward:

- We were one of the first Colleges to introduce and implement new transparency rules that permit patients and others to have access to more information than ever before about physiotherapists on the Public Register.
- Our College led a group of 13 health Colleges (talk about interprofessional cooperation) in an exploration of how clinic regulation might address problems we see in clinics where physiotherapists work but have no control over the quality of the care delivered or the business practices.

And finally, the icing on the cake?

We've created a Citizen Advisory Group that works as a think tank and offers us honest feedback about our regulatory activities. The group has met several times already and they have provided us with great input into what the public needs from the regulation of the physiotherapy profession.


We've accomplished a lot more, but I wanted to make sure I highlighted these accomplishments up front.





## **DISCIPLINE SUMMARIES**

### 2015-2016

Over the past year the College had six Discipline Hearings

### **Ankur Bulsara**

**Discipline Case Summary** 

On January 8, 2015, the Inquiries, Complaints and Reports Committee (ICRC) confirmed that the following concerns related to Mr. Bulsara's conduct and practice while he was affiliated with MyBody Health Institute and/or Spectrum Physiotherapy warranted a referral to the Discipline Committee for a Hearing:

- Assessment and Treatment Practices
- Record Keeping Practices
- Supervision of Support Personnel
- Fees and Billing
- Falsification of Records

The hearing took place on Friday, August 21, 2015. The Panel found that Mr. Bulsara had committed acts of professional misconduct.

### Penalty

The Panel ordered the following penalty:


Mr. Bulsara's certificate of registration will be suspended for six months. Mr. Bulsara will be required to serve only three months of the suspension if he completes the remainder of the Order. The suspension is in effect from August 21, 2015 through to and including November 20, 2015.

- Mr. Bulsara will receive a reprimand.
- Mr. Bulsara will complete a number of practice enhancement activities within 12 months of the Order.
- Mr. Bulsara will participate in a practice monitoring program for two years.
- Mr. Bulsara is not permitted to supervise students or members of the College who hold a provisional practice certificate of registration during the time that his practice is subject to practice monitoring.

- In the event that Mr. Bulsara provides physiotherapy services under the supervision of a registered member of the College (the "supervising physiotherapist") during the period that his certificate of registration is suspended, Mr. Bulsara will, prior to providing supervised physiotherapy services be required to meet certain conditions.
- Mr. Bulsara is required to pay costs to the College in the amount of \$15,000.

### **Judith Hunter**

### **Discipline Case Summary**

On November 25, 2014, the Inquiries, Complaints and Reports Committee (ICRC) confirmed that Ms. Hunter's failure to appear before a Panel of the ICRC to receive a caution warranted a referral to the College's Discipline Committee for a hearing.

The hearing took place on Thursday, April 30, 2015.

The Panel found that Ms. Hunter had committed acts of professional misconduct in that she failed to comply with an Order of a statutory Committee and engaged in conduct relevant to the practice of the profession that, having regard to all of the circumstances, would reasonably be seen by members as disgraceful, dishonorable or unprofessional.

### **Penalty**

The Panel ordered the following penalty:

- That Ms. Hunter shall appear before the Panel to receive a reprimand.
- That Ms. Hunter shall pay costs to the College in the amount of \$2,000.

## **DISCIPLINE SUMMARIES**

### **Aerry Patel**

**Discipline Case Summary** 

On September 16, 2014, a Panel of the Inquiries, Complaints and Reports Committee (ICRC) referred allegations about Aerry Patel to the Discipline Committee for a hearing.

The hearing took place on April 13, 2015.

### **Summary of the Allegations**

Aerry Patel was the co-owner of Square One Physio in Mississauga, Ontario. Mr. Patel's business partners, who is also a physiotherapist, had his certificate of registration suspended between September 21, 2012, and November 2, 2012.

It was alleged that:

- Mr. Patel failed to report to the College that his business partner, SS, was practicing physiotherapy while his certificate of registration was suspended.
- Mr. Patel assisted his business partner, SS, to practice physiotherapy while his certificate of registration was suspended.
- Mr. Patel falsified records and submitted accounts or charges for services that he knew or ought to have known were false or misleading.

### **Findings**

The parties agreed and the Panel confirmed that Mr. Patel had committed the following acts of professional misconduct in that:

- Mr. Patel failed to meet the Standards of practice of the profession.
- Mr. Patel engaged in conduct or performed an act relevant to the practice of the profession that having regard to all the circumstances would reasonably be regarded by members as disgraceful, dishonorable or unprofessional.
- Mr. Patel submitted an account or charge for the services that the member knew or ought to have known were false or misleading.

### Penalty

The Panel accepted a joint submission on penalty as proposed by the parties. In doing so the Panel ordered the following:

Mr. Patel's certificate of registration was suspended for a period of 4 weeks. Mr. Patel was required to serve 2 out of the 4 weeks if he completed the following:

- Mr. Patel received a reprimand.
- Mr. Patel was required to complete an Ethics course.

Mr. Patel completed the Ethics program prior to the hearing taking place.

Mr. Patel was ordered to pay costs in the amount of \$8,000 to the College to offset some of the costs of investigating and prosecuting this matter. This cost order was paid on the day of the hearing.

### **Dimitrios Tsaprailis**

**Discipline Case Summary** 

On September 17, 2015, the Inquiries, Complaints and Reports Committee referred a matter involving Dimitrios Tsaprailis to the Discipline Committee for a hearing.

The hearing took place on December 15, 2015.


### **Summary of the Allegations**

Between the winter of 2012 and October 9, 2013, Mr. Tsaprailis invoiced patients using his name and registration number for massage therapy sessions delivered by SM who was not a registered massage therapist.

Between October 8, 2013, and October 17, 2013, Mr. Tsaprailis fabricated clinical notes for patient files requested by the College.

Between October 8, 2013, and June 29, 2015, Mr. Tsaprailis misled the College and made false representations to the College in response to the College's investigation.

Between the winter of 2012 and October 9, 2013, Mr. Tsaprailis failed to obtain informed consent from his patients for SM's involvement in the delivery of their physiotherapy care, failed to supervise SM in her capacity as a physiotherapy support person and failed to maintain clinical notes and records in respect of patients receiving treatment at the clinic.



### Penalty

The Panel ordered the following:

- a suspension of 6 months
- a requirement that Mr. Tsaprailis receive a reprimand
- a requirement that Mr. Tsaprailis review and complete a number of College resources
- a requirement that Mr. Tsaprailis complete the ProBE ethics course
- a requirement that Mr. Tsaprailis' practice be subject to practice monitoring for a period of one year.

- restrictions related to the supervision of students and physiotherapists who hold a Provisional Practice Certificate of Registration while under practice monitoring
- that Mr. Tsaprailis pay to the College costs in the amount of \$25,000 no later than January 31, 2016.

## **DISCIPLINE SUMMARIES**

### **Jeffrey Scott**

### **Discipline Case Summary**

On July 30, 2015, the Inquiries, Complaints and Reports Committee (ICRC) referred a matter involving Jeffrey Scott to the Discipline Committee for a hearing.

The hearing took place on March 15, 2016.

### **Summary of the Allegations**

During the period of 2009 to April 2015, Mr. Scott submitted invoices to patients that were false, misleading and inaccurate.

Invoices were issued to patients for initial physiotherapy assessments using Mr. Scott's name and registration number when an employee (not a physiotherapist) performed the assessment.

- Assessments and the development of treatment plans were assigned to a non-physiotherapist.
- Mr. Scott failed to obtain informed consent from patients for the use of support personnel.
- Mr. Scott directly and/or indirectly held a non-physiotherapist out as a registered physiotherapist.
- Mr. Scott misrepresented information to the College.

At the conclusion of the hearing, the Panel found that Mr. Scott had committed acts of professional misconduct.

### **Penalty**

The Panel ordered the following penalty:

Mr. Scott's certificate of registration will be suspended for a period of fifteen months. Mr. Scott will be excused from seven months of the suspension if he completes the remainder of the Order.

- Mr. Scott will receive a reprimand.
- Mr. Scott will complete a number of practice enhancement activities within 12 months of the Order.
- Mr. Scott will participate in a practice monitoring program for a period of two years.
- Mr. Scott will not be permitted to supervise students or members of the College who hold a provisional practice certificate of registration during the time that his practice is subject to practice monitoring.

- In the event that Mr. Scott provides physiotherapy services under the supervision of a registered member of the College (the "supervising physiotherapist") during the period that his certificate of registration is suspended, Mr. Scott will, prior to providing supervised physiotherapy services be required to meet certain conditions.
- Mr. Scott is required to pay costs to the College in the amount of \$7,500.

### **Decision**

### Samir Shah

### **Discipline Case Summary**

On September 16, 2014 a panel of the Inquiries, Complaints and Reports Committee referred allegations pertaining to Samir Shah to the Discipline Committee for a hearing. The hearing took place on April 13, 2015.

### **Summary of the Allegations**

Samir Shah was the Co-owner of Square One Physiotherapy in Mississauga, Ontario along with another physiotherapist.

Mr. Shah's certificate of registration was suspended between September 21, 2012 and November 2, 2012 as a result of an order made by a panel of the Discipline Committee of the College. During this time Mr. Shah continued to practice as a physiotherapist. Invoices for services provided during this time by Mr. Shah referenced the co-owner as the provider of record which was incorrect. In addition Mr. Shah falsified records during this period.

### **Findings**

The parties agreed and the panel of the Discipline Committee confirmed that Mr. Shah had committed the following acts of professional misconduct in that he:

- failed to meet the standards of practice of the profession
- practiced the profession while his certificate of registration was suspended
- failed to comply with an Order of a statutory Committee
- engaged in conduct or performed an act relevant to the practice of the profession that having regard to all the circumstances would reasonably be regarded by members of the profession as disgraceful, dishonorable or unprofessional
- falsified a record
- submitted an account or charge for services that he knew or ought to have known were false or misleading

### Penalty

The panel rejected the joint submission on penalty (in part) as presented by the parties and imposed a penalty that reflected a longer period of suspension. The Panel ordered the following:

That Mr. Shah's certificate of registration is suspended for a period of nine months. Mr. Shah will be required to serve six months (of the nine) if he completes the following within the required timelines:

- Mr. Shah will receive a reprimand
- Mr. Shah will be required to complete a number of practice enhancement activities
- Mr. Shah's practice will be monitored for a period of two years following his return to practice
- Mr. Shah will pay costs to the College in the amount of \$12,000.

## **FINANCIAL STATEMENTS**

#### **REPORT OF THE INDEPENDENT AUDITOR ON THE SUMMARY FINANCIAL STATEMENTS**

### THE AUDITED FINANCIAL STATEMENTS WERE ACCEPTED AT THE ANNUAL GENERAL MEETING OF COUNCIL ON JUNE 17, 2016.

The accompanying summary financial statements, which comprise the summary statement of financial position as at March 31, 2016, and the summary statement of operations for the year then ended, are derived from the audited financial statements of the College of Physiotherapists of Ontario as at March 31, 2016 and for the year then ended, on which we expressed an unmodified opinion in our report dated June 17, 2016. Those financial statements, and the summary financial statements, do not reflect the effects of events that occurred subsequent to the date of our report on those financial statements.

The summary financial statements do not contain all the disclosures required by Canadian accounting standards for not-for-profit organizations. Reading the summary financial statements, therefore, is not a substitute for reading the audited financial statements of the College of Physiotherapists of Ontario.

#### MANAGEMENT'S RESPONSIBILITY FOR THE SUMMARY FINANCIAL STATEMENTS

Management is responsible for the fair summarization of the audited financial statements in accordance with the criteria disclosed in the summary financial statements.

#### AUDITOR'S RESPONSIBILITY





### **PATIENT RELATIONS**

There were no new applications for Funding for Therapy and Counselling to the Patient Relations Committee over the past year.

The Regulated Health Professions Act (RHPA) includes a number of provisions to require the reporting of the sexual abuse of patients by regulated health professionals, provide funding for therapy and counselling for patients who have been sexually abused by a regulated health professional and ultimately to eradicate the sexual abuse of patients. The College's Patient Relations program ensures that resources, advice, training and supports are available to prevent the sexual abuse of patients.

In December 2014, the Ontario Minister of Health and Long-Term Care announced the Minister's Task Force on the Sexual Abuse Prevention of Patients and the Regulated Health Professions Act. *www.collegept.org/Public/ProtectingthePublic* 

The College has been an active participant in this Task Force and in 2015, provided detailed information on the current status and operations of its patient relations program's measures for preventing and dealing with the sexual abuse of patients. We eagerly await the Task Force's report.



There were 598 new members registered between April 1, 2015 and March 31, 2016; a decrease of 4.5% from the year before.







## **PROFESSIONAL CONDUCT**

### 2015-2016 By the Numbers

The College receives complaints and reports about the practice or conduct of physiotherapists.

All complaints made by the public are investigated by the Inquiries, Complaints and Reports Committee (ICRC). The Registrar may also initiate investigations where reported information suggests reasonable and probable grounds to believe the physiotherapist may have engaged in professional misconduct.

The results of the investigations are considered by the ICRC, which may take no action, order a range of educational or remedial activities or refer the physiotherapist to the Discipline Committee for a hearing.

The College also receives information about individuals who are not registered with the College but refer to themselves as physiotherapists or physical therapists.


